Employee Welfare

- Audiogram test was conducted for the employees working in relatively high noise area i.e. for employees working in DG and Boiler area by taking care of the side effect that can be caused by the high noise on their physical fitness (E.g. hearing ability loss). Audiogram test is also included in the yearly medical calendar.
- Risk assessments and procedures are in place for pregnant female workers to ensure safe working conditions.
- Awareness over Covid 19 pandemic was given to the employee by conducting awareness sessions and through circulating government posters throughout the organisations before lockdown has been imposed on the Nation.
- Masks were provided to all the employees and practice of wearing it all the time was introduced in the plant. Instruction for frequent hand washing and use of sanitizer were given to all employees before lockdown was imposed.

Environment

- To reduce plastic contamination to the environment we have collaborated with a company called Hanpro Ingenious Pvt. Ltd (HIPL) to recycling or up cycling the plastic waste we have generated from the processes. GRI 307
